OFFICIAL RULES

OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA ("U.S.") AND CANADA (EXCLUDING QUEBEC) WHO ARE 21 YEARS OF AGE OR OLDER.

1. **ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING.** Open only to legal residents of the 50 United States and the District of Columbia ("U.S.") and Canada (excluding Quebec) who are 21 years of age or older at time of entry. Limit one entry per person, regardless if the Entrant has more than one email address.
